I ask that you, as Town of Dryden Clerk, forward this message to T/Dryden Supervisor Leife and to members of the Town Board -- Deborah Cipolla-Dennis, Daniel Lamb, Linda Lavine, and Kathy Servoss -- and I thank you in advance for your help.

As a resident of New York State I am writing in opposition to the expansion of the Dominion New Market Pipeline project. Although permission has been granted to proceed with the project, I do believe there is more that the Dryden Town Board can do. Town Supervisor Leiden wrote two very important letters regarding this issue -- to Governor Cuomo on February 3, 2017 and to Kimberly Bose at FERC on March 6, 2017. I ask that you strongly urge your Supervisor to continue his fight against the expansion of the Dominion New Market Pipeline project and to act immediately as follows:


1. **Rescind local approval** for the New Market **Stormwater Pollution Prevention Plan**;
2. **Require** Dominion to apply for a **Special Use Permit** for the Borger Compressor Station expansion, and then **deny** the expansion because it cannot comply with the Town of Dryden's comprehensive land use plan;
3. **Require** the DEC to check whether any previous spill sites might be affected or impacted by the work to be conducted.

Air and water are essential to human life. We should always do absolutely everything we can to preserve our pure air and clean water. Please look closely at the three steps above and recognize their importance in protecting the health, not only of the residents of the Town of Dryden, but of the many residents of New York State. Kindly remind your Supervisor of the promise he made at the public meeting on May 1st to write to Governor Cuomo.

My family has owned a lovely property on Dodge Road for over 40 years. Although I am in favor of solar energy, I adamantly oppose the installation of this massive, intrusive project in the Ellis Hollow area.

A project of this magnitude does not belong in the quiet, natural areas of Ellis Hollow. Siting should be the key issue, but clearly, very little consideration (except economic) was put into the site selection. Site selection for a solar farm MUST consider the visual impact.
