Be it enacted by the **Town Board of the Town of Dryden** as follows:

(Name of Legislative Body)

- 1. This Local Law is adopted pursuant to authority of Municipal Home Rule Law Section 10(1)(ii)(a)(1) and Section 10(1)(ii)(d)(3).
- 2. The Town Board of the Town of Dryden is hereby authorized to appoint not more than four (4) town constables to have powers in both civil and criminal matters as court attendants and enforcement officers for the Town of Dryden Justice Court.
- 3. Such constables shall be part time, non-competitive exempt employees of the Town and shall serve at the pleasure of the Town Board. They shall be peace officers as defined in the Criminal Procedure Law and enforcement officers as defined in the Uniform Justice Court Act.
- 4. Persons appointed constables pursuant to this local law need not be electors of the Town.
- 5. The Town Board shall fix the hours of work, wages, and terms of employment of the constables which wages shall be in lieu of any other fees or compensation.
- 6. Pursuant to Municipal Home Rule Law Section 22, to the extent the provisions of this local law are inconsistent with Town Law Sections 20 and 23, it is the intent of this local law to supersede such sections.
- 7. This local law shall take effect upon filing with the Secretary of State.
