Local Law No. 5 of the year 2015

A local law **Amending Local Law #2 of 1994 – Sewer use rate SS4, SS5, SS7**
(Insert Title)

Be it enacted by the Town Board of the Town of Dryden as follows:
(Name of Legislative Body)

1. Subsection (b) of Section 6 (Calculation of Sewer Rent) of Local Law No. 2 of the year 1994 (Dryden Sewer Districts Sewer Rent Law) is hereby amended to read as follows:

“(b) Based upon the water usage, the calculation of the sewer rent shall be made by multiplying the number of gallons consumed in the billing period by \$.2271 per 100 gallons. The product shall be the sewer rent for the billing period.”

2. Subsection (c) of Section 6 (Calculation of Sewer Rent) of such local law is hereby amended to read as follows:

“(c) In the event that the product computed according to sub-section (b) above is less than \$22.71 then the bill shall be rounded up to \$22.71 which shall be a minimum bill for each billing period. In the event the premises are not connected to a water meter, then a minimum bill as set forth herein shall be imposed for each billing period, until such time as a water meter is installed. All premises served by a sewer system shall have a water meter installed within nine (9) months of connection of the premises to the sewer system.”

3. This local law shall take effect for all sewer use after January 1, 2016 and after filing with the Secretary of State.


