#### Be it enacted by the Town Board of the Town of Dryden as follows:

(Name of Legislative Body)

- Subsection (b) of Section 6 (Calculation of Sewer Rent) of Local Law No. 2 of the year 2013 (Peregrine Hollow Sewer District Sewer Rent Law) is hereby amended to read as follows:
  - "(b) Based upon the water usage, the calculation of the sewer rent shall be made by multiplying the number of gallons consumed in the billing period by \$.3151 per 100 gallons. The product shall be the sewer rent for the billing period."
- 2. Subsection (c) of Section 6 (Calculation of Sewer Rent) of such local law is hereby amended to read as follows:
  - "(c) In the event that the product computed according to sub-section (b) above is less than \$31.51 then the bill shall be rounded up to \$31.51 which shall be a minimum bill for each billing period. In the event the premises are not connected to a water meter, then a minimum bill as set forth herein shall be imposed for each billing period, until such time as a water meter is installed. All premises served by a sewer system shall have a water meter installed within nine (9) months of connection of the premises to the sewer system."
- 3. This local law shall take effect for all sewer use after January 1, 2016 and after filing with the Secretary of State.
