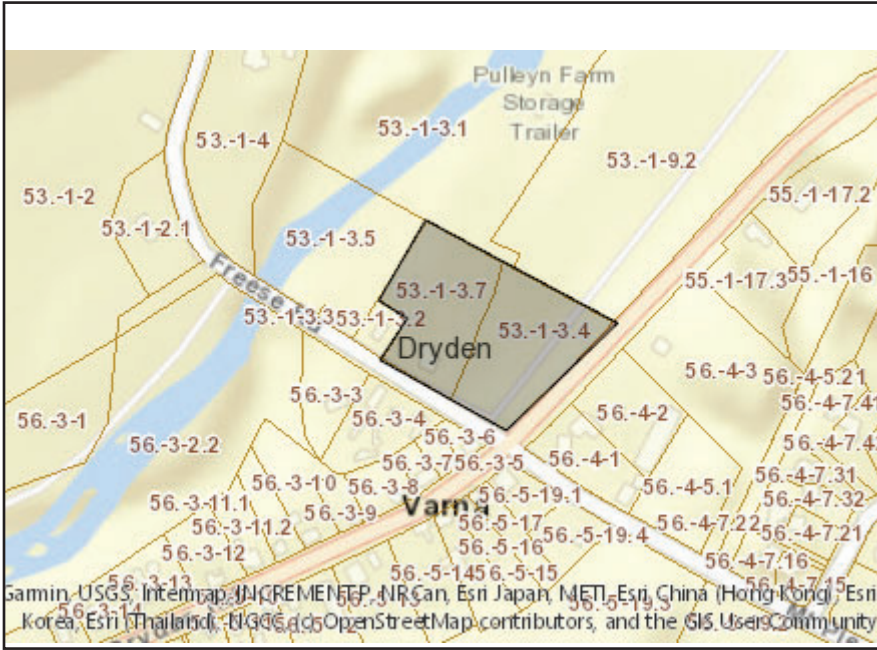

Sewage Loading: As part of original 5 Freese Road project, a sewage load of 9,900 GPD was identified and approved by DEC as part of that project's sewer main extension which included the planned 15-3 bedroom homes plus an additional 15-3 bedroom homes as a future phase. The current proposal includes 5 2 bedroom homes, 10 3-bedroom homes for 5 Freese Road and 64 bedrooms for 9 Freese Road for a total proposed sewage load of 11,440 GPD.
2. The Applicant is not aware of any prior generation, treatment and/or disposal of hazardous wastes at the site. If contamination is discovered during construction, a remedial plan will be developed by a qualified/licensed Environmental Engineer.
3. The Applicant's target demographic includes, but is not limited to, young professionals, graduate/post-graduate students and families.
4. The rental rates for the units will be determined based on market conditions upon completion of the project.
5. The Applicant does not have an anticipated total number of tenants for the proposed units. The development provides 47 dwelling units that will be rented by the unit.
6. The Applicant intends on renting the dwelling units by the unit. If the tenant shares a bedroom within a unit, the Applicant does not plan on limiting this as part of the lease.
