WHO CAN USE SMALL CLAIMS: You must be an individual to use Small Claims. Corporation, Partnerships, Associations or Assignees cannot bring actions in Small Claims Court.

<u>AGE</u>: You must be 18 years or older to bring an action in Small Claims; otherwise, the action must be brought by a parent or guardian.

 $\underline{\mathbf{Costs}}$: Filing Fee - \$10.00 for claims equaling \$1,000.00 or less, and \$15.00 for claims exceeding \$1,000.00.

Both summonses will be mailed by the Court Office and copy will be mailed to you to notify you of date and time of the hearing - bring evidence and witnesses to hearing.
