Be it enacted by the Town Board of the Town of Dryden as follows:

Section 1. Placement of the Billboard Overlay (BO) District.

Those portions of the below listed parcels within One-Hundred and Fifty (150) feet of the centerline of New York State Route 13 are hereby placed within the Billboard Overlay (BO) District. The Town of Dryden Zoning Map shall be amended accordingly.

Section 2. Remainder.

Except as hereinabove amended, the remainder of the Code of the Town of Dryden shall remain in full force and effect.

Section 3. Separability.

The provisions of this Local Law are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words, or parts of this local law or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this local law would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and as if such person or circumstance, to which the local law or part thereof is held inapplicable, had been specifically exempt therefrom.

Section 4. Effective Date.

This Local Law shall take effect immediately upon filing with the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
