**A RESOLUTION APPROVING LOCAL LAW NO. 6 OF 2023**

At a regular meeting of the Town Board of the Town of Dryden held at Dryden Town Hall, 93 E. Main Street, Dryden, New York on the 15th day of June, 2023, the following resolution was offered and seconded:

**WHEREAS**, the Town of Dryden scheduled a public hearing for June 15, 2023 at 6:00 p.m. for Local Law No. 6 of 2023 entitled “A LOCAL LAW PLACING PORTIONS OF TAX MAP NUMBERS 42.-1-2, 42.-9.11, 42.-9.2,11, 42.-44, 42.-31.4, 42.-31.3, 42.-36.2, 42.-35.5, 42.-35.3, 42.-35.2, 42.-36.2, 52.-1-4.31, 52.-4.32, 52.-4.6, 52.-4.11, 52.-4.12, 52.-4.2, 52.-14.1, 52.-14.2, 52.-5, 52.-13, 52.-13.1, 52.-8.5, 52.-8.6, 52.-8.1, 52.-8.2, 52.-8.3 WITHIN THE BILLBOARD OVERLAY DISTRICT”; and

**WHEREAS**, notice of said public hearing was duly advertised in the official newspaper of the Town and posted on the Town Clerk’s signboard; and

**WHEREAS**, said public hearing was duly held on the 15th day of June, 2023 at 6:00 p.m. and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof; and

**WHEREAS**, pursuant to Part 617 of the implementing regulations of the State Environmental Quality Review Act, it is determined by the Town Board that adoption of the proposed Local Law constitutes a Type I Action, as defined under said regulations. The Town Board has considered the possible environmental impacts of the Local Law. The adoption of said Local Law will not have a significant adverse impact on the environment and the Town Board adopted a negative declaration with respect to the Local Law; and

**WHEREAS**, the Town Board, after due deliberation, finds it in the best interest of the Town to adopt said Local Law.

**NOW, THEREFORE BE IT RESOLVED** that the Town Board hereby adopts said local law as Local Law No. 6 of 2023 entitled “A LOCAL LAW PLACING PORTIONS OF TAX MAP NUMBERS 42.-1-2, 42.-9.11, 42.-9.2,11, 42.-44, 42.-31.4, 42.-31.3, 42.-36.2, 42.-35.5, 42.-35.3, 42.-35.2, 42.-36.2, 52.-1-4.31, 52.-4.32, 52.-4.6, 52.-4.11, 52.-4.12, 52.-4.2, 52.-14.1, 52.-14.2, 52.-5, 52.-13, 52.-13.1, 52.-8.5, 52.-8.6, 52.-8.1, 52.-8.2, 52.-8.3 WITHIN THE BILLBOARD OVERLAY DISTRICT”; a copy of which is attached hereto and made a part hereof; and be it further

**RESOLVED** that the Town Clerk be and hereby is directed to enter said Local Law in the minutes of this meeting and to give due notice of the adoption of said Local Law to the Secretary of State; and be it further

**RESOLVED** that this resolution will take effect upon filing with the Department of State.
