- Each fire department shall be responsible for any loss or damage to its fire apparatus sustained in answering any such calls.
- The listed contracts shall be for one (1) year, commencing January 1, 2024.
- Such other incidental terms as may be necessary or proper with such contracting. The following additional term applies to Neptune Hose Company No. 1 of Dryden, Inc., W.B. Strong Fire Company of Freeville, Inc. and the Brooktondale Fire District. Such fire departments or villages shall be responsible for payment of all claims for injuries to or death of fire personnel in connection with such calls.
