**Re: Varna Sanitary Sewer Rehabilitation (Contract A)**

Dear Supervisor Leifer,

On Thursday, October 12th, 2023 three bids were received for the above referenced project. A copy of the bid opening sheet is attached for your information.

The successful bidder is National Water Main Cleaning Co. of Canton, MA with a total base bid amount of \$826,951.67 for a Non-UV cured liner. An alternative bid was received for a UV-cured liner but due to monetary constraints we recommend proceeding with the industry standard for Non-UV cured liner. We evaluated this bid as follows:

- Reviewed all bids for accuracy
- Required the low bidder to complete a bidder's qualification statement and evaluated their current workload and resources available to satisfactorily complete this project. Past projects range from \$99,000 to \$3,661,177
- Verified the low bidder's surety company
- Verified that the low bidder is not listed on the NY State Agency Debarment

National Water Main Cleaning Co. is qualified to complete this work.

The bid will remain subject to acceptance for 45 days after the bid opening, in which the Town has until November 26, 2023 to issue a notice of award. Once the contractor signs the agreement and provides the required insurance certificates and bonds, the Town has 10 days to sign and return the agreement. After the agreement is signed the Town has 30 days to issue the notice to proceed.

Based on our evaluation, we recommend that the Town award the contract for the Varna Sanitary Sewer Rehabilitation (Contract A) to National Water Main Cleaning Co. We recommend the project be awarded for a total base bid amount of **\$826,951.67**. Note, the total project cost will ultimately be determined based on the actual quantities installed. Once the Town passes the resolution, T.G. Miller will prepare a Notice of Award and send it to National Water Main Cleaning Co.
