Brief Description of Proposed Action: The proposed action is an upgrade to the perimeter/security fencing at the Borger Station. The existing chain-link fence will be replaced by a new fencing system which includes two (2) rows of 9-foot tall Palisade security fencing, crash-resistant vehicle gates, reinforcement cabling in roadside areas behind the fence, and pedestrian gates around the fence line. The exterior row of fencing will follow the existing footprint of the current fence line. The purpose of the project is to increase the security of the Borger Station facility and the people who work there.
