Project Description

This is a paving project that begins on Route 13 at Elmira Road and extends north approximately three miles along Routes 13, 34 and 96 to the Ithaca City Line. It also includes the Meadow Street/Fulton Street corridors and work on portions of Buffalo Street, Seneca Street, and Green Street.

In addition to removing and replacing asphalt, work will include updating traffic signals, signs, pavement markings, and drainage. Existing sidewalk and pedestrian curb ramps will be updated as needed to comply with the Americans with Disabilities Act.

Project Schedule

The project is currently in the preliminary design phase. Final plans are expected to be completed and construction set to begin in 2025.

Minimizing Construction Impacts

Road work is expected to take place during nighttime hours, allowing minimal impacts to traffic during daytime hours. Traffic will be maintained onsite, using temporary lane and/or shoulder closures.

Property Impacts

A minimal amount of property is expected to be acquired to accommodate roadside features. Affected property owners will be contacted individually by NYSDOT staff.
